I hereby acknowledge receipt of and assume full responsibility for the dog described above. I agree to maintain this dog as follows:

- The adopted dog is to be kept as a house pet; it shall not be used for medical or other experimental studies.
- The adopted dog will be cared for humanely, including adequate food, shelter, water, preventative veterinary care, and will be licensed in accordance with the law in the jurisdiction in which it resides.
- The dog is to be exercised regularly in a safe manner and not left outside when no one is home.
- I agree to have the dog examined by a veterinarian within two weeks after adoption. If I am not satisfied with the dog's health, I agree to return the dog to PWDCC Rescue immediately. There will be no reimbursement of expenses to date.
- The dog will be spayed or neutered. In extenuating circumstances, the dog may be intact when placed with me and I agree to spay or neuter the dog, at my expense, and provide PWDCC with a veterinary certificate so stipulating.
- The adopted dog may not be transferred to any other person for any reason, if the adopter is forced to relinquish custody of the dog at any time, said dog will be relinquished only to PWDCC Rescue.
- If the adopted dog is lost or stolen, the adopter will notify PWDCC Rescue immediately so we can use our resources to help locate the dog as soon as possible.
- I agree to inform PWDCC Rescue of any major illnesses or death and cause of death of this dog.
- I agree to inform PWDCC Rescue of changes to my address and contact information. This information is strictly confidential and is used for Club purposes only. This information cannot be divulged by the Club or its individual members.
- There will be no refund or reimbursement for any expenses incurred by the adopter for the adopted dog, even if it is returned to PWDCC Rescue. All registration papers or records must be returned with the dog.
- A one-year membership to PWDCC will be provided on adoption of this dog.

Release and Indemnification

I hereby hold harmless and indemnify PWDCC (Portuguese Water Dog Club on Canada) and PWDCC Rescue, its board of directors, its members, officers, agents and volunteers from all claims, demands, actions, causes of action and liability of any kind whatsoever arising as a result of or in connection with the adoption of and the conduct of the dog described above on or after the date of its adoption. I agree to make a contribution to PWDCC Rescue assessed by PWDCC Rescue to assist in the cost of adopting this dog. If any clause of this form is found not enforceable, the balance of the form is still enforceable I certify that I have read, understand and will-ingly agree to the terms of this document and will keep the dog as a part of my family.
